The special meeting of the Public Works Committee was held Wednesday, July 3, 2024 at 4:00pm. The following were notified of the time, date, and place of the meeting: Chairwoman Terry Davis and members of the Public Works Committee, the City Staff, and the press. Present at the meeting were the following: Chairwoman Terry Davis, Council Members: Carolyn Wilson, Kindra Brewton-Pompey (telephone), Department Director Tarus Gilchrist and City Administrator, Holly Jackson.

- 1. Call Meeting to Order & Welcome:** Chairwoman Terry Davis called the meeting to order and welcomed all present.
- 2. Disclosure that local media has been informed of meeting pursuant to South Carolina Freedom of Information Act:** Chairwoman Terry Davis stated the local media had been contacted regarding the time, date, and place of the special committee meeting for Wednesday, July 3, 2024.
- 3. New Business**
 - a. 2015 Freightliner Residential Garbage Truck.** Director Gilchrist went over the needs for a back up trash truck, including needed one to run routes when the existing truck is down for emergency repairs as well as scheduled maintenance. The current truck has been down several times in the last 2 weeks and it has put the crew behind schedule. He then discussed the truck he had located and went to look at in Nashville. He went over the specification of this truck and explained how much it would cost and the delivery. This City has included \$85,000 in the ARP budget for a backup residential garbage truck.

Chairwoman Terry Davis made a motion to purchase the 2015 Freightliner Residential Garbage Truck from the dealer in Tennessee, Mayor Pro-Tem Carolyn Wilson seconded the motion and all signified in favor.
